

violation of plaintiff(s)'s unalienable right of due process in a court of record protected by the 5<sup>th</sup> and 7<sup>th</sup> Amendments.<sup>5,6</sup>

20 Defendants are to take notice that this is a Court of Record which proceeds according to Natural Law under the rules of Common Law, equity rules under USC Title 28 do not apply.

*“Where rights secured by the Constitution are involved, there can be no rule making or legislation which would abrogate them.” - Miranda v. Arizona, 384 US 436, 491.*

25 Whereas; Plaintiff(s) sues Name(s), hereinafter Defendants, for reparations; plaintiff(s) being a natural people preserve's jurisdiction stated above in a court of law that proceeds according to Natural Law independent of enacted law. As grounds in support of removal plaintiff(s) states as follows:

- 1) Defendants via the repugnant and nullified Federal Rule 2 (see Tribunals Decision and Order filed in the above said court dated September 16, 2019 and on the web see footnote),<sup>7</sup> committed Misprision of Treason and Fraud on the Court against the plaintiff(s).
- 30 2) Defendants conspired<sup>8</sup> under color of law in a nisi prius<sup>9</sup> de facto<sup>10</sup> quasi<sup>11</sup> court not of record proceeding “in equity” and not at law.<sup>12</sup>

<sup>5</sup> **Amendment V:** No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

<sup>6</sup> **Amendment VII:** In suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by a jury, shall be otherwise reexamined in any Court of the United States, than according to the rules of the common law.

<sup>8</sup> **18 USC 241:** If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same; or If two or more persons go in disguise on the highway, or on the premises of another, with intent to prevent or hinder his free exercise or enjoyment of any right or privilege so secured They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death.

<sup>9</sup> **NISI PRIUS:** is a Latin term (Bouvier's Law) Where courts bearing this name exist in the United States, they are instituted by statutory provision.; Black's 5th "Prius" means "first." "Nisi" means "unless." A "nisi prius" procedure is a procedure to which a party FIRST agrees UNLESS he objects.; Blacks 4th - A rule of procedure in courts is that if a party fails to object to something, then it means he agrees to it. A nisi procedure is a procedure to which a person has failed to object A "nisi prius court" is a court which will proceed unless a party objects. The agreement to proceed is obtained from the parties first.

- 3) Defendants did willfully injure, oppress, defraud and deprived<sup>13</sup> plaintiff(s) their unalienable right<sup>14</sup> of due process,<sup>15</sup> secured by the Bill of Rights, with the intent to proceed, unlawfully carrying plaintiff(s) away to jurisdictions unknown.
- 35 4) Defendants not being able to prove a claim and fiduciary authority over plaintiff(s) necessary for a lawful seizure of body and/or property in a court of record conspired and devise a plan under the color of law to bypass plaintiff's unalienable right of "due process" in a court not of record, in unknown jurisdictions.
- 40 5) Defendants are fraudulently denying plaintiff's unalienable right of due process in a court of record, that proceeds according to Natural Law protected by Amendments V and VII.
- 6) Defendants, governed by USC Title 18, acted under color of law<sup>16</sup> in one accord and thereby a conspiracy in violation of 18 USC §241 and 18 USC §242.

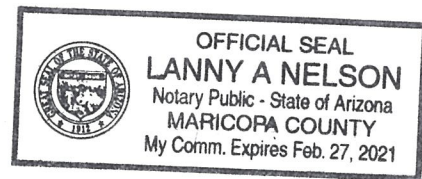
