Subject: **Funding Issues**

Hi John;

When last we talked you brought up the topic of fund raising for NLA and possibly tapping Trump, Musk & Lindell (Pillow guy).

Usually these large organizations funnel their gifting and grants through respective Foundations they have established (tax purposes) and in keeping with gifting & grants, they establish a list of categories that they are interested in funding in relation to their respective interests and furthering same. They then point to these efforts in contributing to societal interests, helping mankind, building their image as "giving back", and such. Money, of course is the driver and self interest in individuals volunteering.

I pulled the Musk site and they fund: Renewable energy, Human Space Exploration, Pediatric Research, Science & Engineering, Artificial Intelligence. Any start-ups or orgs involved in these types of efforts, get first consideration.

Then, grant or gifting requests are followed by formal application for funds and this requires fairly comprehensive business plans on how funds are to be spent. Then the benefactor organization reviews each grant request for alignment with the organization's interests. They review the requesting organization's game plan, track record of previous successes for a ROI and then make decisions. Unfamiliar requesting organizations / sources are measured for benefits to the benefactor's organization. Can be lengthy.

I attached a profile on my Foundation - Clear Path, scope of the work and the Profile and application info for Needful Things, LLC the provider organization.

TRUMP'S Foundation was dissolved by Court Order.

Mike Lindell's - Lindell Foundation contributes toward Drug Intervention programs and community gifting.

We can discuss this more, but most importantly is to develop a business plan for seeking funding and again specifics on what programs, initiatives, staff profiles to engage the work, accountability tied to ROI and other critical needs for application to a benefactor organization like Trump, Musk, Lindell, etc. It will be important to demonstrate successes or progress in Court / litigation work, what initiatives will be pursued using the grants and the administration of the funds. As mentioned previously -

the BENEFITS demonstrated to the benefactor organizations is important as they want to work with winners.

We can talk more on this topic and begin preparations.

My interest would be to establish non -profits / Foundations in each state to underwrite initiatives and personnel (core) in each state and also efforts toward initiatives that are national in nature. State NLA presence could be organized as affiliates.

As the name implies NLA - National Liberty Alliance, the organization does have an interest in alliances (possibly) with other organizations in particular states to work jointly on larger issues being addressed. Rather than a few working on a particular state issue, there could be hundreds in their respective locales working on the same issue and coordinate efforts and timing to achieve greater impact.

In addition, regarding the "new" website (and the NLA organization), establishing a John Dorash Institute on Governance. This could support (financially) your work (teaching and research) and could through endowments support research through doctoral program / research, that NLA has an interest in. This could also include archival provisions for student use.

Lot of possibilities. Lot of work. Increase purpose in membership.
